New Business:

Jo Moore wanted to give a shout out to Rick Burnham on the Library construction, he has been there volunteering almost every day, the construction is going very well.

• Program: Speaker: Danny Lund from Wells Fargo

Danny indicated he is very excited to come speak on something he is passionate about; community involvement. He enjoys working for a company that is passionate about community involvement and giving. Danny has been with Wells Fargo in Orofino for about six months but has been with Wells Fargo for over 5 years. Wells Fargo is very involved in giving back to the community, he will explain first what Wells Fargo has done nationwide and then bring it local. In 2017 Wells Fargo donated 286.5 million dollars to 14,500 nonprofits and schools to support community revitalization, resiliency and economic growth. In addition to that the team members put together 85 million and donated it across 40,000 nonprofit organizations, logging 2 million hours nationwide. In Idaho Wells Fargo donated 945,000 to different nonprofits and schools as well as team members donating 600,000 for different causes. In each communities hours logged for volunteering is over 20,000. In North Central Idaho there has been \$55,000 granted to nonprofits and schools. In our area they have volunteered 1851 hours. They have donated to community action partnership and YCA. In Kamiah they have helped the First Hunt Foundation. In 2018 so far they are on track to eclipse the volunteer hours and financial support. There is financing and resources available to help our communities so if you have questions on grants you can come talk to Danny. The grant process works by completing the online form where it will be submitted to a community involvement committee. The grant will be looked at to see if it ties in with the Wells Fargo vision that states they will help their customers and communities succeed financially. If writing a grant, keep in mind how it will help our community and how many community members the grant will reach. The closer to meeting this vision the more likely your grant will be approved. Grant application asks for at least 90 days for review process. They like to support financial education causes, community stability and development. If you have

any questions and want assistance you can come talk to Danny and he will do what he can to help get the grant request approved. Danny sent kudos to the Orofino Wells Fargo branch, they are a great group of employees. If anyone has any volunteer activities needed, let them know so they can get their volunteer hours in. Other branches can come help also, 12 representatives were here for the community clean up last weekend.
